A significant step closer towards a European Rural Agenda

On the 3rd of October 2018, the European Parliament adopted a resolution in favour of rural territories and the adoption of a strategic framework, the European Rural Agenda.

The European Countryside Movement welcomes the adoption, by the European Parliament, of a resolution in favour of rural territories, which focused on their challenges and concluded as to the necessity to adopt a strategic and an operational framework: the Rural European Agenda.

This decision comes at a convenient time, while the Parliamentary commissions are discussing the future of the European common strategic framework, the CAP and cohesion. The resolution calls for an European strategy incorporating all policies to ensure the development of rural territories, in order to contribute to social, economic and territorial cohesion. Rural territories are part of the solution.

Proposed by the European Countryside Movement, and at the initiative of the international association Rurality-Environment-Development, the resolution has been promoted by the Intergroup RUMRA (Rural, Mountainous and Remote Areas), and in particular by its chair Mrs. Mercedes Bresso, who is working with conviction to promote rural territories.

The collaborative E.C.M. platform brings together 19 European organisations and regularly delivers concrete propositions for a better involvement of rural territories within European challenges. The future of Europe relies more than ever on rural hubs. They are equal actors for territorial cohesion in balance with urban hubs.
