Basic implementation rules

- Possible implementation of single or multi-funded local development strategies
- 1 area - 1 LDS - 1 LAG (an exception made for areas where the fisheries sector dominates)
- key role of Voivodship Self-Governments in the CLLD implementation process
 - Managing Authority for ERDF and ESF
 - Implementing Institutions for EAFRD and EMFF

Available funds

- Total CLLD budget - ca. 900 million €
 - EAFRD (LEADER) – ca. 735 million €
 - EMFF – ca. 19 million €
 - ESF – ca. 75 million €:
 - Kujawsko-Pomorskie Voivodeship – ca. 36 million €
 - Podlaskie Voivodeship – ca. 29 million €
 - ERDF – ca. 70 million €:
 - Kujawsko-Pomorskie Voivodeship – ca. 40 million €
 - Podlaskie Voivodeship – ca. 30 million €



State of Play (April 2018)

LEADER Measure

Applications submitted - 91,77 % of the limit
used

Agreements signed – 48,06 % of the limit
used





State of Play (April 2018)

Implementation of operations under the CLLD strategy

- 16 923 applications submitted (ca. 563 million €)
- 6 609 agreements signed (ca. 227 million €)

Preparation and implementation of LAG's cooperation activities

- 67 applications submitted (ca. 6 million €)
- 34 agreements signed (ca. 2 million €)

Future of CLLD

- more effective coordination of CLLD funds
- more effective CLLD financing method
- the need to rethink the future role of LAG (administrator vs. animator)
- the need to rethink the future scope of LDS (narrow vs. broad)
- A return to 7 principles of LEADER
